## **P09 Crofting project**



#### **Project Overview:**

Crofting is a unique social system which stems from the Highland Clearances of the nineteenth century and has played a crucial role in shaping the landscape, natural environment, cultural heritage and social economy of all the crofting counties. In the project area there are three main areas under crofting tenure: the Coigach Peninsula, the Assynt Coast from Lochinver north to Stoer and then east to Kylesku, and the townships of Elphin and Knockan on the eastern edge of the project area.

Crofting is the primary form of small scale land tenure in the project area and a key part of the social and economic fabric. In addition, crofting land management can have considerable environmental benefits, and perhaps most importantly provides a vital link between the local community and the land.

The aims of the project are to:

- Provide support and practical assistance to crofters throughout the local area to allow them
  to realise their ambitions, make the most of the land under their custody and to encourage
  new entrants.
- Employ a Sustainable Crofting & Rural Projects Coordinator.

Reflecting on the last 5 years, what's the one thing that you're most proud of that has come from your project being part of CALLP?

#### **Setting up of demonstration crofts**

Finding suitable people was essential in getting the demo crofts set up. They engaged with training, planning, resourcing materials and information. They are willing to experiment to see what works and learn by mistakes. It's a great source of pride for them to see the transformation of their crofts.

# What difference has this project made to the built, cultural and natural heritage of Coigach and Assynt?

Crofts have been better maintained/cultivated, drained/ improved the look of. By mowing rank grass and weeds it is better suited to wildlife, sowing of perimeters with wild flower and bird seed improves the provision of food for wild birds. Leaving winter stubble improves conditions for invertebrates and rodents. Having soil analysed, cutting rushes and bracken, improving the pH balance increase grass production for pasture and acts as carbon sink. Providing courses in lime mortaring gives people an opportunity to gain the skills to maintain vernacular buildings

## What difference has this project made to People?

Those involved in delivering this project have acquired new skills with regards to understanding crofting support through government, contacts within the government support mechanism, the Crofting Commission and academe. Local crofters have been encouraged by the demonstration crofts, encouraged to improve croft productivity and gain skills through training.

## **Future Plans and Legacy**

Scottish Wildlife Trust have established a crofting officer post for the next 12 months to continue working with crofters. On the expected completion of the moorland management/township plan the grazings may be able to engage with Agri-Environment schemes. Discussed with local development companies with view to setting up collective growing scheme and composting systems. Crofter will continue to act on lessons learned and information gathered and continue with improving soil either for pasture, cultivation or horticulture. Continue the link between woodland expansion through the Woodland Trust Woodland Expansion post.

#### **Lessons Learned**

What are the three positive lessons gained from the scheme:

- 1. People really enjoyed the social aspect of training as well as what they learned.
- 2. Official advice and support for crofting is available from designated agencies
- 3. Take any help you can get whether from other crofters, neighbours or contractors

What are the three negative lessons gained from the scheme:

- 1. Not all crofters interested, some people are suspicious, and some hostile
- 2. Shortage of contractors, building materials, everything takes much longer than planned
- 3. People slow to react, there is a lot of interest as the scheme comes to a close.


